Major Discussion/Action points

Agenda 1: Chair of the meeting, welcome and sharing of meeting agenda

Chair of the meeting: Mr. Kedar Raj Parajuli, Chief of Nutrition Section of FWD/DoHS/MoHP as well as Nutrition Cluster lead of Federal Leve Nutrition Cluster chaired the session with co-chairing by Mr. Anirudra Sharma, Nutrition Specialist, UNICEF, and co-lead of National Nutrition cluster

Welcome and sharing of meeting agenda: Chair of meeting Mr. Kedar Parajuli welcomed all the participants and Mr. Anirudra Sharma co-chair shared the meeting agenda.

This is the 36th virtual meeting of national nutrition cluster jointly with provincial nutrition cluster after the onset of COVID-19 pandemic. Altogether more than 65 Participants participated in the meeting (see annex 1 for details of the participants list)

Action points:

- Continue orientation of simplified treatment approach to health coordinators of the local governments and health workers of the OTCs.
- Continue service monitoring of ongoing nutrition interventions.
- Preposition of Nutrition commodities for the prevention and treatment of malnutrition in the most emergency affected areas.
- Continue federal government's presence for OTC reviews.
- Identify appropriate way to accelerate implementation of current Fiscal year's AWPB
- Continue regular nutrition program and ensure adequate Nutrition Supplies at all health facilities.
- Provincial Health Logistic Management Center to update the logistic information of the health facilities (OTCs/NRH) and timely supply the nutrition commodities as per demand.
- Identify the appropriate ways to accelerate to implement nutrition programme as per the AWPB of FY 2078/2079

Action points:

Common to all TWG:

- All TWG are requested to meet before the nutrition cluster meeting and discuss about technical issues/matters of nutrition in emergencies.
- The chairs of all TWG need to attend the cluster meeting and brief their concerned TWG progress, issues/lesson learned and way forwards.

IYCF TWG:

- Finalize IYCF-E checklist /tools in our context that developed by Global Nutrition cluster in Nepal context.
- Revise IYCF-E key messages in context of Emergency.

BCC TWG:

- Broadcast radio PSAs on prioritizing pregnant and lactating women during mealtime and for nutritious food continues.
- Initiate communication interventions to promote breastfeeding during upcoming breastfeeding week.

MN TWG

• Discuss and document in the Nutrition technical committee (NUTEC) where already separate technical group is working..

Assessment TWG:

- Reinitiate discussion for SMART survey in province number 2.
- Initiate dialogue to adjust altitude for measuring stunting in new population-based surveys like NDHS, NMICS, NLSS to estimate stunting prevalence. This may appear one of major issues in days to come. It was decided to do a presentation on it in the cluster meeting.

IM TWG:

- Continue covid tracking and 3W mapping from all cluster partners. All partners are requested to fill the tracking sheet and back to the Chair of IM TWG.
- Develop nutrition cluster bulletin.
- Follow with provincial nutrition cluster to update cluster member list of all 7 clusters.

Dr. Taranath Pokharel, Director, Family Welfare Division of DoHS/MoHP:

• Dr Pokharel welcome to New Director General of DoHS/MoHP Dr Ram Padarath Bichha and thanked to all participants for their presence in the 36thy nutrition cluster meeting. And he asked to Dr Bichha to give his valuable remarks.

Dr. Ram Padarath Bichha, Director General of DoHS provided major highlights as follows:

- Dr Bichha was welcomed first by the Dr Taranath Pokharel, Director of Family Welfare Division of DoHS/MoHP and requested to deliver his speech.
- Dr Bichha highlighted that he was Director of Family Welfare Division few years ago and he mostly thinks that he is at Family Welfare Division also.
- He added that because of his background as senior pediatrician, nutrition is in his heart and wants to hear from all that the programme has been moving very smoothly.
- Malnutrition is not a disease but also a complex result of different consequences. Within the definition of malnutrition, overweight/obesity has been an emerging issue also. Therefore, we need to consider malnutrition as a whole such as; stunting, wasting, micro-nutrient deficiencies and overweight/obesity.
- Whatever the rate of stunting has been reduced, that is not enough to for the reduction of malnutrition. All key indicators of malnutrition should be reduced, and we need to work to reduce all forms of malnutrition.
- We need to work for GAP analysis at macro and micro levels and GAP analysis should be done on based on socio-economic status, coverage, and interventions of nutrition programme etc.
- Dr Bichha also gave several examples of Indian experience "Dalia intervention" to bring the change on nutrition situation of children and women through behaviour change communication and specific interventions by using local available nutritious food. He further added the example of Nigeria to improve the nutrition situation of school going children also.
- Dr Bichha also requested to all provincial health authorities to bring innovative ideas to improve nutrition programme also.
- DG felts that the successes DG position depends on the successes of all divisions, provinces including nutrition programme successes at all levels so that he feels proud on this.
- He appreciated Dr Guna Raj Awasthi and hoped that he would work effectively with all stakeholders at all levels.
- Finally, he wished all the best to all participants of the meeting for successful nutrition programming and stopped his speech.

Agenda 6: Closing of meeting

- Mr. Anirudra Sharma, nutrition cluster co-lead and the meeting facilitator thanked to all participants of the meeting and expressed his gratefulness to the Director General Dr Ram Padarath Bichha, Director of FWD Dr Taranath Pokharel, national Nutrition Cluster lead, Provincial Health Directors and representative, representatives from Development partners and all members of provincial and federal level nutrition clusters. He expressed especial thanks to Mr. Kedar Parajuli, the national nutrition cluster coordinator for his active cluster leadership and national nutrition programme. Similarly, he requested to all provincial health team to go through the annual workplan and budget and initiate implementation of nutrition specific interventions on time.
- He further requested to all participants that nutrition is a very important interventions to fight against COVID-19. Therefore, we all need to work together for effective implementation of nutrition specific interventions.

2. Major Progress made after 35th nutrition cluster meeting:

- 1,369 children aged 6-59 months with severe acute malnutrition (SAM) have been admitted and getting treatment in the 768 outpatient therapeutic centres and 22 nutrition rehabilitation homes.
- Ongoing celebration of World Breastfeeding Week (1-7 August) with different programme nationwide.
- Ongoing Infant and Young Child Feeding Counselling for caregivers of children under two years in Point of Entry (PoEs) at the Indian boarders of Lumbini and Sudurpaschim provinces.
- 1,486 G1000D families received nutritious relief packages from the local governments.
- 25,053 relief packages were distributed in isolation centers by the local government equivalent to NPR 72,28,485.
- 2,550 children aged 6-59 months supplemented vitamin A capsules in P1 and Bagamati province. Similarly, 1,916 children aged 12-59 months were deworm in same provinces.
- 66,473 pregnant and postnatal women received IFA tablets.
- 279,522 Households reached with radio messages on nutrition and IPC measures against COVID-19 through 122 FM radio services.
- 213,802 caregivers reached with SMS messages on Infant and Young Child Feeding and caring practices.
- 1,1096 children aged 6-23 months received MNP for the prevention and control of micro-nutrient deficiencies.
- 203,946 Pregnant & lactating women reached with IYCF messages through SMS.

- 34,100 Pregnant and Lactating Women counselled by telephone.
- Completed field tests of national QI guideline.
- Initiated the revision process school health and nutrition guideline with Ministry of Education Science and Technology (MoEST).
- Circulated adolescent IFA guideline through MOEST to all schools.
- Programme of World breast feeding week celebration was circulated to all provinces and local levels through MoFAGA.
- Initiated procurement process of nutrition commodities and opened the BID.
- Completed orientation on "Simplified Approach" for the treatment of SAM and MAM and AWPB for 2078/079 to provincial health and nutrition stakeholders/cluster members and chief and nutrition focal points of District health Offices (DHO) of all 7 provinces. Similarly, same orientations have been completed in 16 districts with OTC review.

3. <u>Issues and challenges</u>

- Limited capacity of local governments to deliver essential nutrition services, early case findings, referral, and treatment of the under five years children with severe and moderate acute malnutrition.
- Lack of sufficient resources to meet the needs of supplementary food to 6-23 months children, pregnant and lactating women in the most affected areas.

4. Way forward/next steps:

- Complete orientation on Simplified approach to the stakeholders of district health offices; and all
 health workers and FCHVs for the treatment of the children 6-59 months with moderate and
 severe acute malnutrition in all 58 IMAM districts.
- Continue service monitoring of ongoing nutrition interventions.
- Ensure preposition of Nutrition commodities including Supercereal for the prevention and treatment of malnutrition in the most emergency affected areas.
- Ensure supply provisions (RUTF) for the treatment of the children under five years with SAM and MAM and increase treatment of SAM and MAM children at the OTCs by using simplified approach.
- Continue federal government's presence for OTC reviews.
- Identify appropriate way to accelerate implementation of current Fiscal year's annual workplan and budget (AWPB) of FY 2078/079 for nutrition specific interventions.
