Major Discussion/Action points

Agenda 1: Chair of the meeting, welcome and sharing of meeting agenda

Chair of the meeting: Mr. Kedar Raj Parajuli, Chief of Nutrition Section of FWD/DoHS/MoHP as well as Nutrition Cluster lead of Federal Level Nutrition Cluster chaired the session with co-chairing by Mr. Anirudra Sharma, Nutrition Specialist, UNICEF, and co-lead of National Nutrition cluster.

Welcome and sharing of meeting agenda: Chair of meeting Mr. Kedar Parajuli welcomed all the participants and Mr. Anirudra Sharma co-chair shared the meeting agenda.

This is the 37th virtual meeting of national nutrition cluster jointly with provincial nutrition cluster after the onset of COVID-19 pandemic. Altogether more than 65 Participants participated in the meeting (see annex 1 for details of the participants list).

Agenda 2: Updates from National Nutrition cluster

MR. Kedar Raj Parajuli, Chief of Nutrition Section of FWD/DoHS/MoHP as well as Nutrition Cluster lead provided the brief update on situation of COVID-19 and nutrition status of country. The updates have been included in Annex II:

Agenda 3: Updates from the provincial nutrition cluster lead (PHD Directors): - major briefs/key achievements, key issues, and way forwards/action points

The Directors/representatives from all 7 provinces presented the overall situation of COVID-19 and progress made by the nutrition cluster of their respective provinces since last meeting, which was held on Friday 22nd Shrawan, 2078 (6th August 2021). Following Directors/representatives presented the major highlights, achievements, issues, challenges, and way forward of their respective provinces as follows:

Action points:

- Continue orientation of simplified treatment approach to health coordinators of the local governments and health workers of the OTCs.
- Continue service monitoring of ongoing nutrition interventions.
- Review the stock of nutrition commodities and request to the Central medical stores on time copying to the nutrition section of FWD
- Preposition of Nutrition commodities for the prevention and treatment of malnutrition in the most emergency affected areas.
- Ensure adequate Nutrition Supplies at all health facilities.
- Initiate broadcasting of nutrition messages through FM radio services nationwide. Development partners are requested to support to the Government for this activity.
- Continue federal government's presence for OTC reviews.
- Identify the appropriate ways to accelerate to implement nutrition programme as per the AWPB of current FY 2078/2079.
- Revitalize the OTCs of Bagamati Provinces which were established during earthquake emergencies.
- Nutrition in emergency preparedness and response plan not yet approved in all provinces except Karnali Province. Therefore, it is requested to all provinces to accelerate the approval process of monsoon response plan.
- Support to organize Palika level nutrition review meeting in all palikas.

Action points:

Common to all TWG:

- All TWG are requested to meet before the nutrition cluster meeting and discuss about technical issues/matters of nutrition in emergencies.
- The chairs of all TWG need to attend the cluster meeting and brief their concerned TWG progress, issues/lesson learned and way forwards.

BCC TWG:

• Bhanchhin Amma design documentation for this Fiscal Year has been prepared in collaboration with Multisector ministries and this design document is in the process of approval. This Bhanchhin Amma design documentation has been focused to all the family members of any families.

MN TWG:

- UNICEF has proceeded for designing and printing of 25,000 copies of CNSI FLIP Chart.
- Received an update from Management Division on bidding process of Procurement of MNP and Vitamin-A.

Assessment TWG:

• SMART survey training was held on district Saptari of Province 2 from 15th to 23rd August 2021. After that the data collection part had completed on 31st August and the team are working on the data entry process.

• IM TWG:

- Continue covid tracking and 3W mapping from all cluster partners. All partners are requested to fill the tracking sheet and back to the Chair of IM TWG.
- Develop nutrition cluster bulletin.
- Follow with provincial nutrition cluster to update cluster member list of all 7 clusters.

Remarks:

Mr. Shalik Ram Bhusal, Under Secretary of Ministry of Education Science and Technology:

- Mr. Shalik Ram Bhusal thanked to all nutrition cluster team for the continuous effort of National Nutrition Cluster to reach till 37th Cluster meeting and provide strong technical support and guidance to organize this meeting in every 3 weeks.
- He explained that the nutrient meals budget has been allocated to all Government schools. And therefore, he requested to concerned stakeholder to support in their respective places/provinces/local government and facilitate to provide nutritious meal at the Government schools.

Dr Jhalak Gautam, Management Division:

• He told that this is the first time he was able to give full time to the National Nutrition Cluster. He was pleased to see the achievement and ongoing progress of the National Nutrition Cluster.

Dr. Bibek Kumar Lal, Director, Family Welfare Division of DoHS/MoHP:

- He further requested to all participants that nutrition is a very important interventions to fight against COVID-19. Therefore, we all need to work effectively for effective implementation of nutrition specific interventions.

Situation of Mansoon Emergencies:

- The monsoon floods and landslides continue to further exacerbate the hardship already caused by COVID-19.
- 55 districts out of 77 have been affected including Sindhupalchowk, Nawalparasi, Myagdi, Manang, Darchula, Kailali, Lamjung and others.
- According to the latest report of NRCS dated 29 August 2021, 64 people have lost their lives, 35 people are have been mission, 69 injured, 5,940 family have been affected, 2,619 families have been displaced and 829 households are fully destroyed, and 931 households are partially destroyed.
- Public properties like schools, roads, bridges, government offices and hydropower stations have been damaged severely limiting access of relief to affected population.
- So far, there is no specific nutrition interventions except ongoing interventions.
- Nutrition cluster is readiness with prepositioning of nutrition commodities as well as readiness of the human resources (HWs and Development partners).

Progress made after 36th nutrition cluster meeting

- 2,427 children aged 6-59 months with SAM have been admitted and getting treatment in the 768 outpatient therapeutic centres in Shrawan and Bhadra 2078 (NRH data yet to receive).
- Ongoing Infant and Young Child Feeding Counselling for caregivers of children under two years in Point of Entry (PoEs) at the Indian boarders of Lumbini and Sudurpaschim provinces.
- 150,737 pregnant and postnatal women received IFA tablets.
- 211,971 caregivers of under two years children received IYCF counselling.
- Initiated procurement process of nutrition commodities and opened the BID.
- 8,907 children aged 6-23 months received MNP for the prevention and control of micro-nutrient deficiencies.
- Completed orientation on "Simplified Approach" for the treatment of SAM and MAM and AWPB for 2078/079 to provincial health and nutrition stakeholders/cluster members and chief and nutrition focal points of District health Offices (DHO) of all 7 provinces. Similarly, same orientation has been completed in 17 districts with OTC review.
- Initiated SMART nutrition survey in Saptari districts and after the survey completed in Saptari, it will be expanded to cover all 8 districts of Province number 2
- Started bidding process for the procurement of Nutrition Commodities such as anthropometric measurement, MNP, vitamin A, super cereal plus.
- Organized monthly virtual meeting of nutrition rehabilitation homes (NRH) on 31st August 2021.
- Organized a meeting to develop Nutrition app (Mero Poshan Sathi) on 26th August 2021.

- With UNICEF's assistance, 8 people (5 from Paropakar Maternity and Women's Hospital, 2 from Family Welfare Division and one from UNICEF) visited to Delhi India to observe Comprehensive Lactation Management Center (CLKMC) including Human Milk Bank from 21-25 August 2021.
- Planned for provincial level CNSI MToT (2 participants one from National Health Training Center, Provincial Health Directorate). Tentative date is 27th Bhadra to 2nd Ashwin, 2078.
- Approved training manual and implementation guideline of Family MUAC approach.

Issues/Challenges

- Limited capacity of local governments to deliver essential nutrition services, identify children with severe and moderate acute malnutrition and admit for therapeutic care and treatment.
- Identified the vulnerable local levels need to BSFP support.
- Delayed in SAM/MAM identification and treatment
- Nutrition in Monsoon preparedness and response

Way forward/Next steps

- Continue orientation of simplified treatment approach.
- Continue service monitoring of ongoing nutrition interventions.
- Ensure preposition of Nutrition commodities including Supercereal for the prevention and treatment of malnutrition in the most emergency affected areas.
- OTC reviews in presence of nutrition section of FWD.
- Accelerate implementation of current Fiscal year's AWPB
- BSFP will be started in all 8 districts of province number 2 with the support of WFP from mid-September 2021.
- Family Support Package (Cash plus component) will be started soon with UNICEF support in Saptari as a COVID Response.
- Effective preparedness and response against nutrition in monsoon emergencies.
- Initiate pilot implementation of FAMILY MUAC approach in 4 districts.
