
38th NATIONAL NUTRITION CLUSTER MEETING VIA ZOOM LINK

After COVID-19 onset, this the 39th meeting of National Nutrition Cluster jointly with Provincial Nutrition Clusters of 7 provinces. The meeting was chaired by Mr. Lila Bikram Thapa, Chief of Nutrition Section of FWD/DoHS/MoHP as well as Nutrition Cluster lead of Federal Level Nutrition Cluster and co-chaired by the Mr. Anirudra Sharma, Nutrition Specialist, UNICEF as well as Cluster co-lead. Altogether 100 Plus participants from different organizations were invited out of which 55 plus attended via zoom link.

Major Discussion/Action points

Agenda 1: Chair of the meeting, welcome and sharing of meeting agenda

Chair of the meeting: Mr. Lila Bikram Thapa, Chief of Nutrition Section of FWD/DoHS/MoHP as well as Nutrition Cluster lead of Federal Level Nutrition Cluster chaired the session with co-chairing by Mr. Anirudra Sharma, Nutrition Specialist, UNICEF, and co-lead of National Nutrition cluster.

Welcome and sharing of meeting agenda: Chair of meeting Mr. Lil Bikram Thapa welcomed all the participants and Mr. Anirudra Sharma co-chair shared the meeting agenda.

This is the 39th virtual meeting of national nutrition cluster jointly with provincial nutrition cluster after the onset of COVID-19 pandemic. Altogether more than 55 Participants participated in the meeting (see annex 1 for details of the participants list).

Agenda 3: Updates from the provincial nutrition cluster lead (PHD Directors): – major briefs/key achievements, key issues, and way forwards/action points

The Directors/representatives from all 7 provinces presented the overall situation of COVID-19 and progress made by the nutrition cluster of their respective provinces since last meeting, which was held on Friday 5th Kartik 2078 (22nd October 2021). Action points:

- Complete orientation of Simplified approach to all health coordinators, OTCs and district health team for the treatment of moderate and severe acute malnutrition
- Guide local levels/health facilities for record keeping and reporting of nutrition service statistics in the DHIS2
- Strengthen monitoring and supervision of ongoing nutrition services
- All provincial health logistic management centers to review the stock of nutrition commodities regularly and timely request to the central medical store copying to the nutrition section of FWD
- Preposition of Nutrition commodities for the management of nutrition in emergencies in the most vulnerable areas.
- Ensure adequate Nutrition Supplies at all health facilities.
- Involve nutrition section of Family Welfare Division of DoHS/MoHP for the orientation of Simplified approach as well as OTC reviews.
- Accelerate to implement nutrition programme as per the AWPB of current FY 2078/2079.
- Revitalize the OTCs of Bagamati Provinces which were established during earthquake emergencies.
- It is requested to all provinces to accelerate the approval process of monsoon/COVID-19 response plan.

- Support to organize Nutrition Review at local level.
- Gandaki province to initiate the expansion process of IMAM programme in the remaining districts such as Syangja, Parbat, Lamjung, Kaski etc...
- Support NRH to timely provide the SAM treatment reporting to the concerned Provincial Health Directorates and Nutrition section of FWD

- Mr. Anirudra Sharma, nutrition cluster co-lead and the meeting facilitator thanked to all participants of the meeting and expressed his gratefulness to Provincial Health Directors and representatives, representatives from Development partners and all members of provincial and federal level nutrition clusters. He expressed especial thanks to Mr. Lila Bikram Thapa, the national nutrition cluster lead for his active cluster leadership and national nutrition programme. Finally, he requested to Mr. Lila Bikram Thapa to close the meeting with the announcement of new meeting date.
- Mr. Lila Bikram Thapa, the lead of national nutrition cluster and Chief of Nutrition Section of FWD/DoHS/MoHP

- The implementation guideline to implement AWPB for FY 2078/79 has been already forwarded to all provinces and local levels. Therefore, Mr Parajuli requested to UNICEF, Suahaara, WFP and other support agencies/development partners to make aware to all local levels about to implement AWPB for FY 2078/079. Similarly, he requested to all provincial health team to go through the annual workplan and budget and initiate implementation of nutrition specific interventions on time.
- Mr. Thapa highlighted again about the flood/landslides situation and explained that due to the flood and landslides, many people are busy to provide the response services. Therefore, all participants couldn't attend in this meeting, and therefore, he requested to all for their presence in the next meeting. Further, he emphasized that the admission rate of acute malnutrition for treatment in the OTCs is very limited. Therefore,

we need to accelerate the screenigng of the 6-59 months children and provide treatment of identified SAM and MAM children effectively at the OTCs.

• He further requested to all participants that nutrition is a very important interventions to fight against COVID-19. Therefore, we all need to work effectively for the implementation of nutrition specific interventions.

2. COVID-19 situation

- COVID-19 pandemic still affecting larger population of the country and smooth operation of health and nutrition programme still effectively not going.
- A new variant of concern of the SARS-CoV-2 virus that causes COVID-19, Omicron, has been detected in several countries.
- According to WHO, as of 8 December 2021, the new coronavirus variant omicron has so far been found in 57 countries,, warning that the rate of hospitalization resulting from infection is likely to rise.
- In Nepal, two Omicron cases have been identified among the migrant population and those cases are now PCR negative.
- Government of Nepal has issues new travel protocol and according to the protocol, travelers arriving Nepal from different 9 countries are restricted such as; South Africa, Botswana, Zimbabwe, Namibia, Lesotho, Eswatini, Mozambique, Malawi and Hong Kong.
- The department of Immigration has advised not to visit these countries mentioned above unless in case of emergency.
- We need to be very cautious about mass gathering, to go to the crowded population, following the IPC measures and social distancing.

3. Progress made after 38th National Nutrition Cluster meeting

- 2,552 (OTC: 2,436; NRH: 116) children under five years old with severe acute malnutrition (SAM) have been admitted in the 817 Outpatient Therapeutic Centers (OTCs) and 22 Nutrition Rehabilitation Homes (NRH) across the country.
- Caregivers of 39,441 children below 23 months received IYCF counselling.
- 90%children (2,183,364 out of 2,437,022) 6-59 months aged received Vitamin A supplements national campaign conducted in in 6-7 November 2021.
- 88% children (1,905,618 out of 2,168,906) 12-59 months aged were deworm in national campaign conducted in in 6-7 November 2021.
- Ongoing support for infant and young child feeding information dissemination and counselling services via telephone, radio, SMS, TV and other social media communication channels.
- Ongoing procurement process of nutrition commodities by FWD and Management Division of DoHS/MoHP.
- Completed revision of nutrition indicators in HMIS and submitted to HMIS section.
- Completed final revision of FCHV flip chart and will be printed soon and distributed to the provinces as per the need.
- 58,755 children aged 6-23 months received MNP.
- 55,282 children aged 6-23 months and 33,355 pregnant and lactating mothers have been benefitted from Blanket Supplementary Feeding Programme in Province number 2, Karnali and Sudur Paschim provinces.
- Ongoing provincial nutrition reviews in different provinces

4. Issues and Challenges:

- The use of essential nutrition services remains low
- Systematic community-based screening of children to detect for wasting remains constrained
- Record keeping and timely reporting
- Limited capacity for the management of nutrition in emergency preparedness and response
- Roles of nutrition cluster technical working group for technical guidance for the management of nutrition in emergencies
- Not finalized NiE preparedness and response plan for provincial nutrition cluster in all 7 provinces

5. Way forward/Next steps:

- Piloting Family MUAC approach in 4 districts
- Continue orientation of simplified treatment approach.
- Continue service monitoring of ongoing nutrition interventions.
- Ensure preposition of essential Nutrition commodities in all provincial warehouses
- Strengthen and expansion of OTCs (minimum one OTCs in one palika).
- Focus to initiate to implement CNSI up to the FCHV levels as per the planning
- Capacity building on nutrition in emergencies and ITC at provincial levels
- Incorporate revised nutrition indicators in HMIS and initiate MAM treatment reporting mechanism through the DHIS-2
- Initiate to form NUTEC at provincial level
